

Manufacturer's instructions and information

Information brochure for personal protective equipment (PPE) according to Regulation (EU) 2016/425, annex II point 1.4. Please read this information brochure carefully before using the PPE. You are obligated to enclose this information brochure when passing on the PPE or to hand it over to the recipient of the PPE. For this purpose, this information brochure may be reproduced without restriction. Protective gloves Risk category II

The CE marking certifies that the product complies with the essential health and safety requirements of Regulation (EU) 2016/425.

This product is personal protective equipment of risk category II. It protects you against: mechanical hazards. Other areas of application than those mentioned above are expressly excluded. This product therefore provides, among other things, no protection against: chemicals, microorganisms, cold, thermal risks (heat and/or fire), electric shock, radiation, highpressure jets. Please note the pictograms, notes and the corresponding performance levels.

Storage / use / servicing: Store in a cool, dry place. Keep away from direct sunlight, UV rays or ozone sources. Do not store in buckled condition or under weight load. If possible, store or transport the product in its original packaging. Influences such as light, humidity, temperature and natural changes in materials over a longer period of time can lead to changes in product properties. Exact information on storage time and service life of the PPE is not possible, since both parameters depend on the respective type of storage, temperature, humidity, degree of wear and intensity of use, among other things. Check this product for damage or material changes (e. g. brittle, cracked coatings / materials, holes, colour changes etc.) after prolonged storage and before and after each use. Before each use, check this product for suitability for the intended activity and for the correct size. Unsuitable or defective products must be disposed of and never used. The size of the product may differ from the specifications, e. g. due to stretching.

All performances were determined by tests under laboratory conditions.

It is therefore recommended to check whether the PPE is suitable for the intended use, as the conditions at the workplace can differ from those of the type examination depending on various parameters (e. g. temperature, abrasion, intensity of use). If PPE has already been used, it can offer lower performance due to the degree of wear. The manufacturer accepts no responsibility for any improper use of the product.

Instructions for wearing the product: Make sure your hands are clean and dry before putting on gloves. Insert your fingers into the respective glove and pull the glove loosely over your hand on the knitted wrist or cuff. Make sure that the fit is correct. Gloves should have a tight and snug fit on the palm of the hand, fingers and gaps between fingers. Fingernails, jewellery, excessive stretching and pulling can damage the gloves. Gloves should be taken off after use in such a way that the outside of the gloves does not come into contact with clothing or skin, as the gloves can be visibly and invisibly contaminated with harmful substances. Accordingly the inside must come outwards. First remove the fingertips of the glove from your fingers. The knitted wrist or cuff can then be rolled outwards in order to remove the glove. To ensure that the glove retains its comfort, it should be cleaned after each use in accordance with the cleaning and maintenance instructions. If necessary, this can and should be done while wearing the gloves.

A suitable skin protection product can be used before starting work (after breaks and if necessary after washing the hands). During work (before breaks and before end of work) a suitable skin cleanser can be used. After work (after the last washing of the hands) a suitable skin care product can be used.

Cleaning / maintenance: The product should be cleaned with a damp cloth (warm water) without chemicals or by brushing and dried in the air. Check this product for damage after cleaning and before wearing it again. Do not reuse damaged products. Depending on the type of cleaning, this can have a negative effect on the performance of the product. The manufacturer accepts no responsibility for any improper cleaning of the product.

Disposal: Dispose of with household waste. This product may be contaminated by environmentally harmful or hazardous substances after intended or unintended contact with chemicals. In this case, disposal must be carried out in accordance with the local legal regulations.

Special notes: PPE can cause allergic reactions. Special care is recommended in case of known hypersensitivity.
